6. Protection and Welfare of Children – This section may need to be updated to ensure that practitioners are aware of their obligations under the Criminal Justice (Withholding of Information on Offences Against Children and Vulnerable Persons) Act 2012 and may need to be further updated following enactment of the Children First Bill.

10. Conscientious Objection – This section may need to be strengthened to ensure that under the Protection of Life During Pregnancy Act 2013 that patients who may have a life-threatening illness are referred immediately to a physician who does not have a conscientious objection.

12. Appropriate skills and facilities – The IMO are concerned about the impact of successive budget cuts on patient safety - the guidance and the Medical Council must support doctors who have serious concerns about their ability to deliver safe care to patients with restricted resources.

18. Adverse Events – Poor communication with patients following an adverse event is a common cause for complaints against medical practitioners. This should be highlighted. Legislation is needed to protect physicians from admission of liability when apologising to patients.

21. Abortion – As per 10 above

23. Medical Records - a supporting booklet might be useful to guide medical professionals with writing and maintaining medical records.

43. Children and Minors – a supporting booklet would be useful to support physicians with consent to treatment of mature minors.

49. Health Resources - As per 12 above the IMO are concerned about the impact of successive budget cuts on patient safety - the guidance and the Medical Council must support doctors who have serious concerns about their ability to deliver safe care to patients with restricted resources.

50. Professional Indemnity -The IMO would advise all physicians to ensure they are adequately indemnified. Newly registered doctors should be advised on registration to take out clinical indemnity insurance .

53. Clinical Trials and Research – This section should be updated to reflect the amended WMA Declaration of Helsinki - Ethical Principles for Medical Research Involving Human Subjects.

54.5 Provision of Information to the Public and Advertising –The IMO and European medical professional bodies are concerned and opposed to the development of Standards in aesthetic surgery and non-surgery services by CEN (The European Committee of Standardisation) an industrial standards body. The concerns of the medical professional bodies in Europe have been previously expressed by the IMO to the Medical Council. There is an urgent need to ensure high standards and regulation of the advertising and provision of cosmetic and plastic surgery services at National level.

Currently there is a two-tier health system in Ireland, many practitioners in Ireland treat both public and private patients. The IMO support the introduction of a universal healthcare system. The Guidance should highlight medical practitioners obligation to ensure that patients are treated on the basis of need and practitioners do not prioritise private patients above public patients.

There are some risks for medical practitioners in the use of social media.
